Preschool Extended Care Fees 2021-2022

Preschool Extended Care (PSEC) provides childcare for registered preschool students before and after school. PSEC is available for all registered preschool children on the days they are registered for school. Pricing for Full Day and Half Day PSEC/AM/PM include snack and milk fees.

Available PSEC spots are limited and intent forms are due no later than May 28, 2021 in order to be eligible for consideration. Spots are on a first come, first serve basis with priority consideration given to existing STVP families/students and parish members. Any registrations received after this date may be put on a waiting list and families will be notified by July 1, 2021 of availability.

A registration fee of \$50.00 per family, per year due at time of registration.

Payment Options for Preschool Extended Care (PSEC):

1. Full payment made directly to the school office by June 12, 2021 will receive a \$40.00 discount.
2. Full payment made to the school office after June 12, 2021 but before the first day of school will be accepted at the full rate.
3. Monthly automatic withdrawal/payments for PSEC are made through FACTS Management Company from your checking or savings account or credit card (fees may apply). Payments begin in July 2021 and all PSEC fees must be paid in full by May 2022.
